Partnerships

Taxfiler includes full support for preparing and filing partnership tax returns, using the same straightforward processes used to file for individuals.

If you have prepared partnership or LLP accounts using Taxfiler, then you can simply transfer the account figures directly into the partnership tax return to ensure the trading pages are populated correctly.

Allocating profits to partners is simple, and you can link in each partner's individual record so the data is seamlessly updated to their own personal tax return.

All the supplementary forms are available, as is the ability to handle investment partnerships, partnerships with multiple trades and partnerships with a mix of personal and corporate partners.



Trusts and estates

Select from a variety of trust types, including charitable and non-resident trusts. Entering details of trust income and allowable expenditure is quick and easy, and you can also input details of beneficiaries and any discretionary payments made.

Taxfiler will compute the tax payable by the trust, including any tax due on discretionary payments, and will also perform the necessary tax pool calculations.

Taxfiler will also generate R185 forms containing the details of trust payments, and these can be distributed to beneficiaries as required.


